### Designated Safeguarding Leads for Alternative Providers

#### Outline

This is for professionals who will be taking on the role of DSL or Deputy DSL in an Education setting eg school/academy, college, alternative provider, apprenticeship training etc.

#### Description

The training will cover the current national and local safeguarding issues and all the elements set out in "Keeping Children Safe in Education" Annex B - "Role of the DSL", including: relevant legislation, statutory guidance, managing referrals to children's social care, child protection case conferences, record keeping, internet safety, Prevent etc.

#### Outcome

Qualified to take the role of DSL or Deputy DSL in an Education setting. This must be renewed every two years.

\* Attendees must attend both sessions to receive certification.

#### Audience

Attendees from outside Leicestershire are welcome.

This is not aimed specifically at Early Years and is not for Governors.

This is for Alternative Providers only.
